<b>Flood Plain Permits</b>	Property size is less than one-half (1/2) acre	\$200.00
	Property size is greater than one-half (1/2) acre	Same as fees for SLU application

<b>Plat &amp; Subdivision</b>	Filing Fee (later given to County Clerk)	\$20.00
	Inspection & examination fees (1-25 lots)	\$50.00
	Inspection & examination fees (26-50 lots)	\$75.00
	Inspection & examination fees (51-100 lots)	\$100.00

<b>Zoning Verification (Effective 7/1/2002)</b>	Verify property zoning via phone or fax (no letter)	No charge
	Verify property zoning on letterhead paper (typed)	\$25.00
	Verify property zoning and zoning compliance on letterhead (requires submission of letter requesting the service, and ALTA survey, applicable building use data, and appropriate fee).	Same as Site Plan Review fees based upon lot area.
