RECREATIONAL FIRE PERMIT APPLICATION

PERMIT IS VALID: April 1, 2019 – March 31, 2020

PERMIT COST: \$50 (After October 1 permit is prorated to \$25.)

BURNING PERMITTED ON: Friday, Saturday and Sunday from 5:00 p.m. –12:00 a.m. Midnight

EXCEPTION: May burn on following holidays from 5:00 p.m.–12:00 a.m. Midnight

- Permit is strictly for Recreational purposes only
- Burning area must be 3 ft. or less in diameter and 2 ft. or less high
- Burning of building material or non-wood items is strictly prohibited
- Burning of brush, leaves, grass or trash is strictly prohibited
- The fire must be continuously attended
- A water source must be readily available
- Fires in approved containers are required to be at least 15 feet from any structure
- Fires in an in-ground pit are required to be 25 feet from any structure
- The Fire Marshal Division reserves the right to revoke any Recreational Fire Permit for violation of any of the above regulations and or Fire Code
- Please be aware that wind and weather condition could cause your recreational fire to be unpleasant to others. If this is the case the Fire Department could ask you to put your fire out.
- Issued permit shall be kept on the premises designated therein at all times and shall be readily available for inspection. VIOLATION of permit conditions MAY RESULT IN A \$150.00 CIVIL INFRACTION TICKET AND/OR TERMINATION OF PERMIT - NO WARNINGS!
- **Note: Recreational Fire permits are allowed for 1 or 2 family dwellings only.**
